- Sealed Quotations must be submitted to the above on or before 12:00 hr on **2075-07-29**, Quotation received after this deadline shall not be accepted.
- Quotations must be valid for a period of 45 days after opening of sealed quotations and must be accompanied by Cash Security or Bank Guarantee, amounting to a minimum of *amount as specified in table above*, which shall be valid for 75 days after opening of the Sealed Quotations.
- If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.: *4140303007105 Rastriya Banijya Bank, Gulariya Branch office, Bardiya* and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
- Sealed Quotations shall be opened in the presence of Suppliers' representatives who choose to attend at 13:00 hr on **2075-07-29** at the Gulariya Municipality.
- If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day.
- If bidders are not manufacturer, they must submit sole authorization letter from the manufacturer or from the authorized distributor of the manufacturer.
- In the case of discrepancies or error in bid documents, bid notice or any other documents, Gulariya Municipality reserves the right to amend and correct at any time. The figure for the bid amount must be clear if any discrepancy may occur then the figure written in word is valid.
